Dear GI-TOC colleagues,


This general document will give you access to the most necessary informative resources, increase knowledge about the inner workings of our organization and thus form a more cohesive understanding of our work behind-the-scenes.

Membership overview and current gaps

From 27 members at the creation of the organization, the GI-TOC Network of Experts counts no less than 707 members to date (June 2024). The GI-TOC Network of Experts strives to be a fair representation of the high-level experts working on transnational organized crime issues around the world.

- Key role of the Network: Annual General Meeting, the organization's highest authority, which convenes once a year.
- The Network has the authority to appoint members of the Board, and to appoint a select number of its own members to the Board to represent the Network.

Civil society organizations: 181 (26%)


Independent experts: 208 (30%)


Government and law enforcement: 211 (30%)

- The Membership Review Committee considers the profiles of prospective members after a thorough background check has been carried out based on our Code of Ethics. Those who are approved by the committee are formally invited by the director to become GIN members.
